# **AGC Decision Report**

## 7.16 Common Syllabus Update

#### Approved by AGC Executive Committee February 15, 2024

#### **Decision**

On December 12, 2023, the AGC membership voted to approve changes to an update to the Common Syllabus as follows:

- 1. On page 2 of the current common syllabus template there is a section titled "14 Day Attendance Rule". This title will be changed to "Reporting of Student Non-Attendance and Withdrawal"
- 2. The content under this new title shall read as follows:
  - "When a student has not attended a course within a 14 calendar day period in accordance with the class attendance policy, this absence is recorded in the college's grading system. This would initiate a withdrawal of the student from said class. Students must understand that they are responsible for classwork missed during an absence, doing any extra work that may be required to replace in-class activities, and that missing class will impact student learning and may negatively impact grades. Each faculty member's attendance policy, as stated in the course syllabus, is the final authority on any academic consequences associated with missing a class."

## Sponsor/Champion of Proposed Policy

Chair: Valerie Butterfield (Registrar)

#### Rationale

The GRCC Attendance Policy was updated in April 2023. That attendance policy change included language that allowed for the earlier reporting (within 14 calendar days) of students that never attended or that stopped attending. After implementing these changes for Fall 2023, questions arose from some faculty and students related to the clarity of the language in the common syllabus template. To address that concern, this language update re-titles the 14 day attendance rule to "Reporting of Student Non-Attendance and Withdrawal". The new language now utilizes language directly from the attendance policy statement and clarifies student responsibility related to class absences.

# **Supporting Data**

The sponsor of this modification to the common syllabus document solicited input from AGC during two presentations. As the change proposed was not a substantive change to the policy or its associated policy document, a third presentation was not required.

### **Implications for Action**

This change does not substantively alter college procedures and is made only for clarity.
